# **Independent Directed Studies Policy**

## PURPOSE OF THIS POLICY

In conjunction with British Columbia's Ministry of Education, ASCEND Online offers students the chance to pursue curriculum in more detail, by focusing on the learning outcomes of a course that they're not taking. In doing so, ASCEND Online – through Independent Directed Studies – will grant credit towards graduation for learning that has been assessed and matches or exceeds provincial, national or international standards.

For graduation purposes, credits for Independent Directed Studies may only be used to satisfy the elective requirements. As a reminder, students must complete 16 credits of electives, along with 64 credits of required courses, in order to graduate from ASCEND Online. Grade 12 credits may count toward the minimum of 16 Grade 12 credits required for graduation.

Independent Directed Studies must be based on the learning outcomes of Ministry-Developed or Board/Authority Authorized Grade 10, 11 or 12 courses.

## **PROCEDURE**

## **Student Requirements:**

To participate in this method of learning, students must:

- 1. Demonstrate the ability to work independently.
- 2. Complete an IDS Proposal Form and submit it to the ASCEND Online High School Academic Advisor.
- 3. With their teacher, draft an Independent Directed Study plan that includes:
  - i. a process for ongoing facilitation and assessment.
  - ii. criteria for determining successful completion.
  - iii. a credit value (1, 2, 3 or 4 credits) for the proposed IDS.

## **Proposal:**

A student who is interested in pursuing an IDS must draft a plan and submit it to the High School Academic Advisor of ASCEND Online. The Academic Advisor will consult with a school based team to determine approval of the proposal. The school based team may be comprised of any or all of the following members: High School Advisor, Principal, Vice-Principal, High School teacher(s), previous K-9 Contact Teacher (to help determine suitability of student requirement #1 above).
